This program is fully accredited by the American Dental Association's (ADA) Commission on Dental Accreditation (CODA) and is recognized by the New York State Department of Education.

The site includes the number of available positions for the Academic School Year 2013-14, pertinent information regarding admission/eligibility requirements, a listing of all the Eastman Institute for Oral Health training opportunities and a Q&A segment.

4. Application completion and submission:

5. Selection/Interview Process: The review of applications and selection of applicants for interviews are granted once per cycle and will be conducted in October and November of the year preceding the start of the program for which you are applying.
