NYS Burn Disaster Plan Informational Session HPP #13

Background:

In the event of an mass casualty incident (MCI) individuals with burn injuries will be provided the best available medical care at a Burn Center or other Burn Disaster Receiving Hospital (BDRH) consistent with 10 NYCRR § 708.5 and 10 NYCRR § 405.22(c) to the extent possible. Under declared disaster or emergency conditions medical care will be allocated to provide the greatest benefit to the greatest number of victims. This situation can depend on a number of factors including the MCI location, hospital bed availability, number of victims, the extent of their injuries, etc. Ideally, the majority of victims with moderate or major burn injuries will eventually receive definitive treatment at a Burn Center. If the number and extent of MCI related burn injuries exceeds the available resources it is likely that not all burn victims from an MCI will receive initial care at a Burn Center.

Goal:

The informational session will focus on three areas of the burn plan:

- Overall emergency management
- Clinical considerations
- Information sharing; and
- Communications
