This is an exciting time for Jones Memorial Hospital.

The 18 months between January 2019 and June 2020, were marked by a number of events that will have a long-range impact on the hospital and the community, including the expansion of our oncology and infusion services in Olean and a \$17 million transformation grant that will ensure a bright future for local healthcare and Jones Memorial. Both the hospital and the laboratory were fully recertified by The Joint Commission this year. HANYS recertified Jones Memorial as a Stroke Center. We also changed to a fiscal year that ends on June 30th.

Of course, 2020 was also the beginning of the global Coronavirus pandemic, which brought incredible and unexpected challenges to everyone in healthcare. The kindness and support of our community continues to be a positive during these troubling times. Every gift of food, flowers, headbands, Tupperware, chalk art, cards, or Personal Protective Equipment is a reminder of how much our community cares about the frontline workers at Jones Memorial Hospital.

Throughout the COVID-19 crisis, Jones Memorial worked closely with the Allegany County Department of Health and the University of Rochester to put in place measures to keep our patients and our staff safe. Healthcare is an essential service so it was vital that we remain open and available for our community. In addition to implementing very limited visitor policies, universal masking, and a mandatory health screening station in the main lobby, we offer drive-up COVID testing by provider referral. Communication is key to managing any crisis and this one is no exception. With daily updates from infection control and employee health, our team continues to monitor the situation and make adjustments to policies as needed.

A team is defined by the strength of its leaders and Jones Memorial was very pleased to welcome Dr. Kevin McCormick as the Medical Director. Dr. McCormick is responsible for the management of the medical staff, acts as a liaison with administration, and is involved in the recruitment of new providers. James Knapp and Ian Jones joined the board of directors, as did Dr. Zahi Kassas, who is the chief of the medical staff. James Helms, the Vice President of Finance at Jones Memorial, was named as the Chief Financial Officer at both Jones and St. James in Hornell. In this new position, Mr. Helms oversees the financial operations of both hospitals, including financial policies, financial strategic planning, cost management, budgets, financial reports, funding streams, and the finance staff at both locations.

OB Offers Nitrous Oxide: Jones

Memorial became the first and only facility in the region to offer Nitrous Oxide for relief from pain during labor to pregnant women delivering there. Also known as laughing gas, nitrous oxide is safe for mother and baby and many women find it helps them relax and decreases their perception of labor pain without affecting infant alertness. Self-administered using the Pro-Nox nitrous oxide delivery system, the staff and patients are very pleased with this option. Taking a moment to demonstrate the system are Jackie Adrian, RN, director of maternal nursing, and maternity nurses Sandra Moore, RN, and Kristina Willets, RN.

Bringing specialty care close to home was one of the goals when Jones Memorial and UR Medicine affiliated in 2015. The new providers who regularly consult and treat patients in Wellsville include Urologist Zaheer Alam, MD and Physician Assistant Chelsea Jones; Pain Management Specialist Gabriel Yacob, MD; Otolaryngologist Bulent Mamikoglu, MD; and Oncologist Neeta Soni, MD. Dr. Soni, who had a very busy private practice when she joined the medical staff, also sees patients at Jones Memorial's UR Medicine | Wilmot Cancer Institute Oncology & Infusion Center in Olean. Pathologist Dr. Maria Reyes was named the medical director of laboratory services when Kirk Heriot, MD retired from that position.

The Jones Memorial Medical Practices welcomed General Surgeon Du Nguyen, MD to fill the vacancy left when long-time surgeon James Edmonston, DO, announced his retirement. Orthopaedic services were expanded when Travis Ely, PA, joined Dr. Paul Axtell in the JMH orthopaedic clinic. When our women's health office in Hornell moved to the brand new Hornell Medical Arts building, Emily Walsh, PA, joined the team, providing gynecological care under the guidance of Dr. Anna Haring. In rehab, Speech Language Pathologist Sara Carbone Hess and Audiologist Chelsea Freeman now provide those services.

Our management staff also welcomed several new members to the team. Mark Brophy was named Director

of Materials Management when Edward Wilson retired after over 30 years in that position. In the pharmacy, we welcomed Jacob Milliron, PharmD, to the leadership role. Jake was later invited to join the HANYS Infection Control Stewardship Council. Leading the patient care area is Daniel Covel, RN, the director of Acute Care Services. Daniel oversees medical/surgical, respiratory therapy, and the critical care unit. Jodie Howe joined the finance team as the Director of Finance at Jones Memorial and at St. James.

With the stated goal of providing quality care, close to home several departments underwent certifications and re-certifications, added services and equipment, or certifications. Both the Pulmonary and Cardiac rehab programs are now certified by the American Association of Cardiovascular & Pulmonary Rehab. The Jones Memorial Medical Practices primary care offices located in Wellsville, Belvidere, and Bolivar achieved Patient-Centered Medical Home certification, as did the pediatric practice in Wellsville. The Space Lab Clinical Monitoring system for inpatients was upgraded this year.

We could not be prouder of our staff and their accomplishments and recognition. Mike Roncone in Facilities achieved OSHA 10 certification; Bizzy Perrin is now a Certified Pharmacy Technician; and in Medical Imaging, Hali Williamson is a registered sonographer and Sydnee Slocum is now certified in adult echocardiography. In 2019, Jones Memorial was notified that we have been selected to receive a \$17 million NYS Healthcare Facility Transformation Grant. Submitted over two years ago, the project will include three capital improvement projects: adding a third floor to the 1993 addition for desperately needed physician offices and the services to support those offices, expanding and modernizing the surgical services suite, and creating a permanent MRI suite with state-of-the-art

equipment. The grant will also fund an initiative to integrate behavioral health and primary care.

Next year, Jones Memorial Hospital will celebrate **100 Years** of Caring. So many aspects of healthcare have changed since our first patient was admitted on June 27, 1921, but our commitment to provide the highest quality healthcare with a hometown touch for our families, friends, and neighbors has remained. FOUNDATION:

Dr. F. Clifton Miller Trust Fund: The Dr. F. Clifton Miller Trust Fund is used for projects and equipment that benefit women and children. The first item purchased using these funds certainly fits this criteria: a V-Scan portable, handheld ultrasound scanner. They are available for purchase at the Women & Children's Health Office and the medical imaging department at the hospital, all proceeds go to the Trust Fund.

Hand Held Ultrasound for Dr. Nguyen: Supporting the medical staff by providing needed equipment is one of the goals of the Annual Fund Drive at Jones Memorial. This year, the Foundation purchased a Mindray 7 portable ultrasound for Jones Memorial Medical Practice's General Surgeon Dr. Du Nguyen. In his practice, Dr. Nguyen has a daily need for the capabilities of the handheld ultrasound. One example of how it can be used is a non-surgical inspection of suspicious masses to determine a plan of care. CEO Eva Benedict and Dr. Nguyen both thanked the Foundation for their generosity.

determined group dedicated to raising funds used to support patient care at Jones Memorial.
