Description:

The Texas Engineering Extension Service (TEEX) will be offering this course. This course is a guide for jurisdictional public health officials and their partners to coordinate plans to provide mass distribution of medical countermeasures as they relate to the Division of Strategic National Stockpile (DSNS) and Emergency Support Function #8 (ESF #8). The purpose of the course is to begin (or expand upon) the local jurisdiction's mass prophylaxis planning process. This course is a two day workshop and facilitated discussion covering the CDC's Strategic National Stockpile, and the local jurisdiction's role in distributing those resources during a bioterrorism, contagious disease or chemical exposure incident.

Course Objective:

Apply knowledge, skills, and abilities to prepare or refine the jurisdiction's Mass Prophylaxis Plan:

Describe the role of epidemiology before and during a mass exposure incident and its relevance to the Mass Prophylaxis Plan; and

Recognize the contents of the SNS and the process by which the SNS is deployed

Prerequisite:

Participants are highly recommended to complete the introduction to the Strategic National Stockpile (SNS) and Mass Prophylaxis on-line course (WMD-AWR 201) at <http://www.teexwmdcampus.com>.
