



Dear Parent/Guardian,

Your child's science teacher or community group has scheduled a visit to the Life Sciences Learning Center (LSLC) at the University of Rochester or an LSLC On the Road lesson at a designated community location (please contact your group organizer for details). The LSLC is a unique hands-on science education laboratory with programs for middle and high school students and teachers. We also offer lessons where parents and students can learn and work together. All LSLC laboratory activities are age and grade appropriate.

**Safety Guidelines**

We ask that visiting participants be responsible, safe, and courteous towards colleagues, instructors, and staff. Please review the following guidelines with your child prior to their lesson.

1. No food or beverages (including chewing gum) are allowed in the lab.
2. Students must keep all cell phones, MP3 players, etc. turned off and stowed in their bags during laboratory sessions.
3. Lab coats and safety glasses will be provided by LSLC and must be worn by all students and teachers performing experiments.
4. LSLC equipment and reagents must be used only as directed.
5. Report spills and breakage immediately to LSLC staff.
6. Running and roughhousing are prohibited in the laboratory as well as in corridors and elevators.
7. Students may not enter into other parts of the building unless accompanied by a LSLC staff member.
8. In the event of a fire alarm, exit the lab immediately in an orderly fashion. A staff member will lead students to the designated safety area.

**Risk and Liability**

While every effort has been made to provide LSLC visitors with a safe science laboratory experience, we are unable to anticipate every situation that could arise. The Life Sciences Learning Center, its staff, and the University of Rochester assume no liability with respect to accidents or injuries that occur during laboratory teaching sessions. In consideration for allowing my child to participate in the University of Rochester field trip, I understand that participating in any activity involves a risk of injury or other harm. All such risks are being assumed knowingly and voluntarily, including but not limited to those associated with travel to and from the program, and I will not hold the University, its employees and agents responsible for any injury or other harm that results from program participation.
