#### **Excellent Patient Advocate**

Judy Brustein, NP in collaboration with the Nurse Practitioner Association on April 25, 2017 went to Albany, NY to lobby for an important bill "The DNR Bill S.1869 Hannon & A.7277 Gottfried". This bill is very important to the Nurse Practitioner's in NYS and their patients. When the NP discusses the patient goals of care and decisions about any medical limitations of treatment, these are documented on a Medical Orders for Life Sustaining Treatments (MOLST). Currently the NP is not authorized to sign the MOLST even though they are having the discussion with the patient. If this Bill is passed it would empower the NP's who are completing the MOLST to legally be able to sign the documentation as a completed order. This ensures the patients' wishes are respected and implemented without delay. "Go Judy-Thank you, for advocating for our patients and the NP Profession at large."
