The American Association on Health and Disability (AAHD) is conducting a confidential, real-time online assessment of the impact of the coronavirus (COVID-19) pandemic on healthcare and healthcare access among persons with a range of disabilities. ## COVID-19 & Medicaid, Advocacy Resources and Governmental Resources.

While CMS has not issued a Special Enrollment Period (SEP) as a result of COVID-19, many of the state-based marketplaces (SBMs) have decided to offer a SEP for COVID-19. Since our newsletter two weeks ago, five of the SBMs (Colorado, Connecticut, Nevada, Rhode Island & Washington) have extended previously announced SEPs for COVID-19. You can find the full list of SBMs who are offering SEPs and their deadlines in our [news item](#).

While a SEP for COVID-19 may not be available to those located in the federally facilitated marketplaces, consumers could be eligible for regular SEPs if they recently lost their coverage due to a loss of job or loss of income. AAHD has been working with Community Catalyst and other partners in conducting outreach to educate individuals about health insurance literacy, special enrollment periods (SEPs) and other issues related to healthcare enrollment. You have options.

It should be noted that people who lose coverage due to a layoff have 60 days from the date they lose their coverage to enroll through the job loss SEP.
