HEALTHY POLICY IN SPAIN OFFERS INSIGHTS INTO A ZERO SECONDHAND SMOKE FUTURE

Recent legislation in Spain has introduced stricter smoking bans, increasing prohibited areas to nearly all public spaces, including on terraces, campuses, swimming pools, public entertainment areas, bus stations, work vehicles, and within a close vicinity to all educational, health, cultural, and sports centers, as well as parks and children's playgrounds. This policy offers a model for tobacco reform in the United States, demonstrating how legislation can advance public health.
