

URMC Malpractice Premium Differential Program 2018 Qualifying Activities Updated August 2018

Those who wish to qualify for the lower rate for the next calendar year (2019) need to have met one of the following requirements between January 1 and December 31, 2018.

For those who have never done so before, participation in a URM TeamSTEPPS Fundamentals Course will be the only qualifying activity. Also, an activity with the same content should not be used to qualify in consecutive years.

The qualifying activities for this year's program include:

- 1) Participation in a URM TeamSTEPPS Fundamentals Course (General or Office Practice).
Dates: General Course Sat Nov 10 & Tues Nov 13. Office Practice Course Sat Nov 17 & Thur Nov 29. All 8am-12n
- 2) Participation in a URM TeamSTEPPS Coaching Course. This is open to those who completed any TeamSTEPPS Fundamentals course.
Dates: Sat Nov 17 8am-12n, Tue Nov 27 4:30pm-7:30pm, Thu Nov 29 4:30pm-7:30pm
- 3) Participation in a URM "Teaching for Quality (Te4Q)" Faculty Development Program (either new participation in a Te4Q didactic program or successful completion of a Te4Q project during this year).
Expected dates: two day program in November
- 4) Participation in a completed URM-sponsored ABMS Portfolio Program MOC (Maintenance of Certification) Part IV approved quality improvement effort with sufficient participation during 2018. **Please note that this is NOT the same as individual ABMS Board MOC programs.**
Application deadline mid-August
- 5) Participation in the URM Patient Safety Certificate Course and receiving a qualifying certificate by attending at least 8 of 11 sessions for the February 2018 - June 2018 course.
- 6) Participation in the New URM Improvement Science Certificate Course and receiving a qualifying certificate by attending at least 8 of 11 sessions for the Sept 2018 – Jan 2019 course (if needed the final 2 sessions in early Jan 2019 can count towards the 8 needed).
New course begins September 6, 2018
- 7) Participation in a URM Risk Management Seminar.
Dates: Saturday December 1 8am-12n and Monday December 3 8am-12n
- 8) Participation in a URM Fundamentals of Quality Improvement Course.
Part II evening course July 9, 2018. Expected date for next Part I evening course in December 2018.
- 9) Participation in a URM Patient & Family Centered Care advanced training program – either individual coaching or sufficient attendance at a PFCC face-to-face program (PFCC program certificate required)
- 10) Participation in the Medical Faculty and Clinician Wellness Series and receiving a certificate by attending at least 7 different sessions during 2018 (Wellness Series CME certificate required)
- 11) Participation in either a one or two day URM Crucial Conversations Course (certificate required, there is a fee).
One day focused class Sept 28. Traditional two-day classes: Mar 16&23, Apr 18&25, May 11&18, Oct 2& 9, Nov 1&8, 2018
- 12) Participation in the Physicians and Attorneys Cooperative Education (PACE) program (PACE certificate required)
To be announced later if there will be a program this Fall
- 13) Participation in the UR Pursuing Excellence leadership program January or October, 2018.

Clinical Service-Specific Options

- 14) Participation in an approved Service Specific seminar or series with sufficient content on patient safety/risk management issues - e.g. Anesthesiology ASA program, ED RQI, Geriatrics, Hospital Medicine, Orthopaedics annual program, Palliative Care ACT program, Primary Care Network, or Bias Reduction in Internal Medicine (BRIM) program (certificate required for each)
- 15) For those practicing Obstetrics who have already participated in a TeamSTEPPS Fundamentals Course, again the only way to qualify will be successful completion in 2018 of the APS OB GNOSIS Fetal Assessment & Monitoring Course **and** participation in at least one multidisciplinary Obstetrics TeamSTEPPS-oriented Simulation at SMH or HH.
- 16) For Neonatologists who have already participated in a TeamSTEPPS Fundamentals Course, an alternative option includes participation during 2018 in at least 6 CME Fellows Conferences **and** participation in at least one multidisciplinary TeamSTEPPS-oriented Simulation along with Obstetrics participants at SMH or HH. Alternatively, Neonatologists may qualify through options above.

Equivalent Programs

- 17) Successful completion of an equivalent face to face (not online) program of patient safety or risk management education, such as attendance at a specific conference at URM or out of town with such content, with approval based on a sufficient safety or risk management focus of the program's agenda, and with receipt of at least 4 hours of patient safety or risk management related AMA Category 1 CME credit. If advance assurance is desired that an equivalent program will qualify, please share the program description and agenda with Dr. Panzer.
